Even minor mistakes or late filing of reports to the government may lead to directors facing harsh criminal penalties. In some cases, these penalties exceed those for arson or rape, whether non-compliance was intentional or not!
- 2. Some statutes are subjected to the Act on Phinai Fines Proceedings, B.E. 2565 (2022), which transforms some laws that originally imposed criminal offenses and administrative offenses with fines into phinai offenses. For more information, please see our <u>article</u> on the phinai fine.
